1. I am aware that cycling, and in particular competitive cycling, involves the possibility of injury or death.

I understand and agree that I participate in this race entirely at my own risk, that I must rely on my own ability in dealing with all hazards and that I must ride in a manner which is safe for myself and all others. I am aware that when riding in this event and particularly when riding on a public highway the function of any marshals is only to indicate direction and that I must decide if the movement is safe. I agree that no liability whatsoever shall be attached to the race organisers in respect of any injury, loss or damage suffered by me in or by reason of the race, however caused.
3. I understand that SOLE RESPONSIBILITY FOR MY PERSONAL SAFETY REMAINS WITH ME, including my physical and emotional preparation and fitness to participate in this event
4. I understand that proper head protection in the form of a cycling helmet is mandatory for participation in this event.
5. I undertake and agree to remove myself from participation if I sense or observe any unusual hazard or unsafe condition, or if, at any time, I feel unable or unfit to safely continue for any reason.
6. I understand entry fees are non-refundable once received by the organisers.
7. I AGREE NOT TO SUE the race organisers from all expenses, fees, liability or damage award or cost of any type whatsoever arising from my participation in this event.
8. I HAVE READ AND UNDERSTOOD THIS WAIVER, RELEASE AND INDEMNITY. I am aware that by signing this agreement I am waiving substantial legal rights (on my behalf and on behalf of my heirs, executors, administrators and next of kin), including the giving up of my right to sue.
